

**APPLICATION FOR PERMIT TO LAUNCH A MOTORBOAT AT
FOUNDRY DOCK PARK**

The Scenic Hudson Land Trust, Inc. owns Foundry Dock Park, located on Market Street in Cold Spring, Putnam County, New York. The park is free and open to the public. To launch a motorboat at the park you must obtain a permit issued by the Village of Cold Spring. A total of five (5) permits are issued per month. Each permit allows the applicant to launch and retrieve his/her registered motorboat for a period of one month starting at the beginning of the month, subject to all applicable rules and regulations.

In addition to completing this application, the following requirements must be met:

1. Only registered motorboats 18 feet in length or less are permitted.
2. Only outboard motors 20 HP or less are permitted; no out drives (aka inboard motors).
3. Only licensed single-axle trailers are permitted.
4. Monthly permits are issued to a specific boat for unlimited launching throughout the month (March through November) in which they are issued, provided the owner/operator of the boat must abide by the established rules and regulations, which are attached.
5. The applicant may not apply for a permit in two consecutive months unless it is determined, by checking with the Village during the last week of the month, that there is a permit available (one of the five) for the following month.
