


Who's Who Among Trustees

DONALD TROST, President — A resident of Garrison for 28 years and building inspector of Philipstown since 1972, Trost was treasurer of the Teachers Income and Annuity Association in New York until his retirement. For the last three years he has operated a gun shop in Cold Spring. He and his wife, Jane, have two children and seven grandchildren.

As a member of Butterfield's board for seven years Trost is a great fan of the hospital and its staff and its service to the community. He views the hospital's move toward a proposed merger with Putnam Hospital Center and Vassar Brothers Hospital as a potential enhancement of the medical care of the community.

EZRA PRENTICE, Vice President — A member of the New York City law firm of Cadwalader Wickersham & Taft and a resident of Philipstown since he left the U.S. Army in 1946, Prentice joined the Butterfield board in 1979.
